

- 3. From the Application Page, complete the following fields
 - 1. Property Selection From the dropdown, select **Guarantor Application.** Do not select the property where the tenant you are serving as Guarantor for will be residing. Doing so will take you to the Tenant, not the Guarantor Application
 - 2. Email Enter the email address you would like to use for your online account and to receive documents and communications about the tenant account
 - 3. First/Last Name Please be sure to enter your LEGAL name. Using nicknames/name variations can prevent the system from recognizing and identifying you during the screening (I.e. Becky/Rebbeca, Bill/William,
 - Rod/Rodney)

 4. Current Address Address where you are currently residing
 - 5. Phone Number This will be the phone number kept on file for us to contact you. Please use the number you would like us to use to reach out to you.
